

ENTRY DEADLINE: All entries must be received or postmarked by March 9th, 2012. Space is limited. Late entries will be accepted with a \$15 fee space permitting. No refund after the deadline. No entry will be accepted without an entry form.

ELIGIBILITY: All participants must be USATT or ITTF current members. If not, must buy USATT membership with the entry form.

FORMAT: All singles will start with a round robin followed by a single elimination playoff. Doubles are single elimination.

EQUIPMENT: Orange '3-stars' NitakU premium balls supplied by Paddle Palace and ITTF approved Killerspin, Joola and Butterfly tables will be used. ITTF approved Stag floor mat on all courts.

ENTRY FEE: Each Singles event \$25, Doubles \$15 per player.

RULES:

- O All USATT regulations, include equipment, conduct, dress, and language apply.
- O All matches are best of 5 games to 11 except Open Singles quarter-finals, semi-finals, and final that is best of 7 games to 11.
- O There will be NO gluing at the venue. It is recommended that players come with two legal rackets and two distinctively colored shirts.
- O Players must arrive at least 30 minutes before their starting time.
- O Ratings in the Jan / Feb. 2012 USATT Magazine will be used to establish eligibility.
- O The most recent rating will be used for seeding. Estimated ratings for new players will be accepted from USATT certified coaches.
- O Un-rated player may or may not advance from the preliminary round robin at the discretion of the tournament director.
- O U3200 Doubles event: all participants must be rated under 2000 (No un-rated players).
- O U4200 Doubles event: all participants must be rated under 2500 (No un-rated players).
- O Players entering the Over 40 and over 50 event must be over that age by December 31, 2012.
- O Juniors must be under the age of their event on December 31, 2012.
- O All decisions of the tournament referee will be final.
- O Prize will be forfeited if the match is not played unless approved by the tournament director.
- O Events may be canceled or combined if needed. Fees will be refunded if canceled.
